President's Report - Scott Poupart

Since our May meeting, I have had the honor of representing our association on several different occasions. In some cases, I have reached out to my vice presidents for assistance with these. The unprecedented wildfire season in New Brunswick and throughout the country led to several requests for interviews from different media outlets. Combined with requests for interviews on the current situation with volunteer recruitment, medical downloading, amalgamation concerns and our training regimes for our firefighters in support of the wildfire campaign, it was a busy period.

In early July, I attended the 2025 Atlantic Leadership Conference in Summerside, PEI. The conference presented several interesting presentations relating to the current all hazards aspect of firefighting. This was our first initiative under our leadership development program and I was accompanied by Charles MacNeil and Tim Corbin, who we sponsored. We will get feedback from each during their Association reports. Charlie Kavanaugh will also report on this.

On September 3rd, I attended the AMANB World Cafe in Grand-Bouctouche. This interactive workshop, based on the speed dating model allowed municipal representatives from around the province to have a short 15-minute interaction with many of the twenty various organizations represented at the workshop. Mike Lewis and I had several interesting interactions which highlighted that there are still many of our newly formed municipalities struggling with how to manage and interact with their fire services. In all cases we offered support and urged those in need to reach out for guidance.

Sept 21<sup>st</sup> to 24<sup>th</sup>, I attended the CAFC Fire-Rescue Canada Convention in Winnipeg. Many of the presentations were around wildfire response as well as the effects of the increasing wildfire threat to the economy. The conference also allowed for valuable networking with our colleagues from across the country and reinforced that our challenges are much the same as those from across the nation. Dwayne Stephenson and Roger Pitre attended the conference under our leadership initiative. Other attendees from New Brunswick included Charlie Kavanaugh and Jody Price.

There is valuable information, programs, and training available through the Canadian Association of Fire Chiefs (CAFC) website for members. I strongly encourage all members to join and take advantage of these resources. Membership provides access to important updates, national initiatives, and discussions on key issues affecting the fire service industry across Canada.

I have also represented the association at several other meetings throughout the period since our last meeting including TSAC, FCBNB, 9-1-1 Face to Face Consultation and JEMC Face to Face held last week in Fredericton, a summation and ask for input on the province's initiative to increase and streamline interoperability during multi-jurisdictional responses. Justin McGuigan will report further on this.

After a recent Governance review in Nova Scotia, that province has reached out for information on firefighter training in the province. I sat in on the original call along with FM Mike Lewis, NBCC Serge Gallant and members of his team, both can comment further on this.

During the period since our last meeting, I have also signed off on letters sent on our behalf to Premier Holt and various Ministers on a Community first restructuring of New Brunswick's paramedic system.

A letter of appreciation for support of the CAFC's efforts to create a national fire administration. A letter requesting the fast tracking of legislative change addressing the firefighter presumptive cancer legislation which includes increasing the number of presumptive cancers covered, streamlining the administrative processing of claims and including wildland and industrial firefighters and provincial fire investigators.

A letter to the OFM on behalf of our career Chiefs on the municipal fire prevention discussion relating to inspections. I have continued to sit in on the monthly NAC meetings as our representative on the CAFC, on several of these Roger has sat in as well.

Our main initiatives remain the same with a current push to see the creation of a national fire administration. Since the change of federal government during the last election there seems to be less appetite on behalf of the government to add another office within the government. We are circulating a copy of a petition in support of MP Gordon Johns' M-12 motion to establish the Office of the National Fire Administration located within Public Safety Canada.

We will forward this to all of our email lists, but we need your support in pushing everyone in our departments to fill these in and send them by mail. Note this needs to be mailed but does not require postage.

Discussion took place on cell phone Service. Motion by Charles Kavanaugh to reach out to those in charge, Public Safety to help improve cell service. Seconded by Harry Farrell. Voted upon and passed

Lastly, I will send out a link to the results of this year's fire census for your perusal I move the approval of my report as presented, seconded by Charles Kavanaugh.

Report for the Maritime Fire Chiefs Association (MFCA) - Charles Kavanaugh We met last week in Saint John, New Brunswick. This is where the 2026 convention will be held, July 16 - 19. While we were there, we met with Fire Chief Nicol about the conference and to see what they may be able to help out with.

We would like to put out a call for future topics. Prince Edward Island received three new fire trucks that can accommodate the coroner services that they provide on the island.

## New Brunswick Association of Industrial Fire Chiefs (NBAIFC) – Scott Worden

NBAFPO (Jeremy Stuart)- April 26-28, 2024, at Fredericton Inn. 83 Registered (were hoping for 70) so good turnout. Three good out-of-province guest speakers including one from Regina and one who presented at NFPA last year from the City of Montreal. Jeff Waters-Gray: A lot of our previous fire prevention has focused on-site, but this year will focus more on off-site, i.e. employees' homes, etc. I really like the newsletters you send out. Patrick Lanteinge: NFPA is excellent, giving out boxes of free materials. Also, could someone share the link for the newsletter or Facebook page for the NB Association of Fire Prevention Officers.

NBAFC (Scott Poupart, Scott Worden) - Non-refundable tax credit is now \$5000 for provincial, \$6000 for federal. Speaks volumes for how the government feels about the fire service. We now have a seat with WorkSafe NB to talk about the Presumptive Cancer Legislation. We are one of only two provinces that have a separate Firefighter Compensation Act. Slows the whole process down. What we've brokered and they've agreed to is that they merge the Firefighter Compensation Act with WorkSafe.

Through the OFM, the NBAFC got a grant of almost \$500,000 for fire prevention training tools for the different associations. Get involved with your local associations because you have access to these tools too. We are working with WorkSafe and the OFM to change the definition of firefighter to include industrial members so that we are included in the legislation. We have put in our part to WorkSafe, will check with Mike that the OFM has done their part as well. It will need to be changed in the actual legislation, so it will take some time.

How much will it cost? Already paying \$500/firefighter. If everyone pays, it will not be much of an increase and if it becomes legislation, there won't be a choice. As an association, we (the NBAIFC) represent about 200 firefighters so it's worth the effort to be included in the legislation.

NBFFCB/NBCC (Jeff Waters-Gray) - Not much to report

#### Next Generation 9-1-1 Committee –Justin McGuigan 24 October 2025

Regional Fire Dispatch -The status of regional fire dispatch remains unchanged from the previous report, which was:

Regional Fire Dispatch is essentially complete, with almost all fire departments that want to participate having been already onboarded. The next big wave of impacts for Regional Fire Dispatch will take place at some point in the future when the formal regionalization or consolidation of fire departments takes place. Some fire departments and municipalities will want to have all their fire departments/fire stations on the same talkgroup, and some will not.

NB 9-1-1 - The annual face-to-face meetings hosted by NB 9-1-1 took place in Fredericton on October 15 and 16. NBAFC Scott Poupart was in attendance. Justin McGuigan was also in attendance for Fredericton Fire and EMO. The annual meeting is an opportunity for NB 9-1-1 partners to get together for professional development and to learn about new opportunities for improvement in New Brunswick.

A keynote address was offered by David Boyle, Lead Chief Superintendent (Bedfordshire Police, UK) who delivered a presentation focused on Joint Emergency Services Interoperability Program (JESIP). JESIP is a framework that emergency responders can use to clearly communicate the details of emergencies and responses using clear and standardized terms. JESIP also ensures that all pertinent information is included. The second keynote address was offered by Dr. Nicola Power, Senior Lecturer in Psychology, University of Liverpool, who discussed how human factors impact multi-agency interoperability and communications. Both sessions were informative and thought-provoking. The remainder of the meetings discussed cybersecurity, and held open discussions about the PSAP services throughout New Brunswick, and the inconsistencies between them. Discussions also revealed how various agencies had different expectations in how an incident may be handled in their area.

Next-Generation 9-1-1 - NG9-1-1 is a new edition of the 9-1-1 system imposed by the Canadian Radio-television and Telecommunications Commission (CRTC). The CRTC has ordered that the system be equipped to receive calls for help in a variety of ways, including by text, and that it tracks the deployment of services up until they arrive on scene, rather than only up to the time they were dispatched. The NB fire service will see very little change. Live testing in Bathurst was delayed but is scheduled to begin this fall, after which it will be rolled out to other PSAPs across New Brunswick. A variety of stakeholder conversations have taken place; Chief Dwayne Killingbeck (Fredericton) sat on all four steering committees, and all known concerns have been addressed. The Province of New Brunswick has done a great job anticipating and mitigating concerns brought forward by the responder community. The key takeaway is that the CRTC is clamping down on the requirement that all dispatching information remain within Canada's borders—data will not be permitted to route through servers outside the country. This will impact some fire departments whose third-party dispatch apps, such as eDispatches, route data internationally. Those departments will need to find new solutions that comply with the CRTC requirement, and a variety of Canadian options are available.

#### **OFM** –Mike Lewis

Mark Nowlan - Mark Nowlan passed away peacefully on Tuesday, October 24<sup>th</sup>. Mark was a fire service leader in this province, whose impact touched everybody in this room. More details will be distributed to the NBAFC and Capital District in the days and weeks to come regarding a celebration of life.

TSAC – Junior FF - OFM is formalizing guidance for departments considering developmental (junior) firefighter programs, including legislative requirements, consent, supervision, etc. This is intended to apply to individuals aged 16, 17 and 18.

MBU Schedule - MBU season is over-now re-evaluating schedule for next year. Share feedback with Remi St. Coeur.

Mental Health Course - Done and translated. The course will be in January on the OFM website. ICE Program. Working on a pilot program through education which will see 16, 17 18-year-olds attend and take the FF1 program through their high school curriculum. Will present to NBAFC once complete.

Minimum Chiefs Guidance - At the request of UMNB-we are compiling information on what soft and hard competencies a fire chief should have. Once prepared, we will share this with NBAFC for commentary.

Major Fire Investigation Trailer - Have relocated the mobile 'major fire investigation' trailer to two separate areas as a deterrent 'billboard'. If your region is seeing several fires, reach out to Jeff if interested.

SPU and MARS program - This summer, OFM activated its Structural Protection Unit program. Firefighter training was not yet complete, but NB Departments stepped up immensely. Over 400 FFs from 30 departments attended over 5 weeks. A lot of feedback and learnable, almost all positive. Over the winter we will formalize SPU policies-training for fire departments first began in Capital District this fall, and will be offered twice annually in rotating areas. The idea being that **most** SPU deployments in the future will be with FF's who have taken training.

Smoke Alarm Campaign - Highly successful-over 12,800 smoke alarms distributed across the province. Winners will be announced in November-many thanks to all who participated.

Fire Prevention Trailers - Visits are slightly down this year. Still a great tool, looking to ensure we maximize use. Will work with PFI's and departments to try and prioritize high-traffic events (Ex, exhibition or festival VS open house). PFIs may be reaching out if they know a high-traffic event is occurring to see if they'd like a trailer. Also looking into the possibility of 'buying' trailers back from NBAFC to reduce insurance costs (10-12k). If feasible, it will require a vote from NBAFC.

Fire Prevention Props - Fire Extinguisher Props (LION extinguisher and interactive screen) as well as hazard houses available from your local PFI. Contact them if you want to borrow it.

Fire Department 'Report card' - Working with PFI's to create a simplified annual 'check-in' with departments to track progress. Deliverable would be a 1–2-page summary of the department and its challenges/successes, to be revisited year over year. This would allow the PFIs to better track changes over time, provide provincial statistics, and provide guidance to municipal officials.

OFM Staff changes (past two years) - Susan Gamble and Fiona Sinclair have both retired-we thank them for their cumulative 40+ years of service to the OFM. Dan Fairbanks joined as a fire plan review officer. He also comes from a GSAR background and will be supporting in that capacity. Karine St. Coeur and Theresa Blizzard have joined as administrative officers. Trevor Tompkins has joined as a FPO in the Saint John area. Matt Cassidy has joined as a PFI in the Fredericton area.

Upcoming opportunities as an Industrial FPO (provincial), and Fire Plan reviewer (Fredericton).

## Aboriginal Committee - Corey Nicholas No Report

## **NBCC** – Serge Gallant

**Accomplishments** - The Curriculum assistant position has been filled. Karine Michaud from Bathurst Fire is the successful candidate. She started on March 10<sup>th</sup>, 2025.

The Fire Services Coordinator position has been filled. Suzanne LeBlanc from BSA is the successful candidate. Suzanne has been with the team for over a Month and is fitting in perfectly in the role.

ICE program started back in September with 16 candidates. They are writing Blk A next week. (Visits can be arranged for anyone looking to see how the program runs)

Using an NBCC truck (Peterbilt) and NBCC driver or a hired driver proved to be the best option for 2025 and will continue in 2026.

**Future** - Continue upgrades to the FTC training site. The Training Site is available to Associations and departments that wish to use it for training at a cost associated with the materials used.

Planning has started to replace and refurbish the live burn prop at FTC.

The 2025 Fire Service Workshop was cancelled, discussion on offering multiple Leadership sessions during the late fall – spring season. Will keep members posted.

<u>Updates-</u> Please inform your association members that Logbooks need to be completed properly with all supporting documentation before sending. We see numerous logbooks missing signatures and supporting documents daily.

A TSAC ad-hoc committee was struck to create an Instructor review program. (Explain). Pilot online course for Instructor 1 is done. Report presented at TSAC, we are looking at running a second option with modifications (some face-to-face).

Amalgamation is still causing some issues as we have departments not updating FIRS/OFM on new org charts. OFM sent a memo, and we are working on a form for Municipalities to complete and send in.

The Safety Officer program committee is working on the Curriculum ICS 200: working with EMO on getting interested instructors wanting to deliver via NBCC. Driver Operator / Defensive Driving / Arial: 3 separate committees starting to work on these programs in November.

Working with the NS Fire Marshal and Fire Service as they are in a transition period.

#### **Local Government**- Ivan Corbett

Disappointed with the low census results. Will be seeking a rural district manager posting for North West, Restigouche and Chaleur. Hoping to do interviews by the end of November. 9 fire trucks in the process. All expected in 2026. Looking to order another 6 trucks.

The Local Government Fire conference will be in Fredericton at the Fredericton Inn on the 28<sup>th</sup> & 29<sup>th</sup> of November. The notice was sent out by the OFM.

## **Department of Natural Resources and Energy Development (DNRED)** - Tony Cole

**Fire season 2025** – This season brought many NB firsts for our fire program. In the history of the province, we had never brought in external personnel resources until this year. We brought Firefighters from Maine, Nova Scotia, PEI, Quebec, Ontario, and Parks Canada. We also brought Aircraft from Alberta, Ontario, Quebec, and Newfoundland. At one point, more than 70 personnel from out of province were assisting with multiple fires. In addition, we leaned very heavily on the Municipal Fire Service. Hopefully, Mike can share numbers. We are grateful for your answering the call on our behalf.

On August 16, we had 44 fires burning at once. This forced us to allow several fires to free-burn while we focused on priority fires threatening people, homes and critical infrastructure. Many evacuation advisories were sent out affecting more than 1000 homes, as well as 1 evacuation alert affecting 2 residences and 28 cottages. No homes were lost. The new structure protection trailers were put into action, and several homes and cottages were saved as a direct result. Two of these fires remain under patrol today.

More than 55 Dozers were used to construct many KM of fire guard and reclamation is currently underway on several fires. We utilized more than 4 railcars' worth of long-term retardant concentrate. This equates to more than 1.5M liters of long-term dropped from aircraft. We had 17 airtankers and 6 helicopters in the province for several weeks. We had 9 firefighters suffer from heat stroke and 1 firefighter injured from a falling branch.

For comparison, we had 437 Fires so far for 3407.6 ha burned in 2025. The 2024 season had 265 fires for 198.3 ha burned. The previous 10-year average is 249 fires for 434.0 ha burned. The 25-year average is 277 fires for 408 ha burned.

This year marks the 200th anniversary of the Great Miramichi Fire of 1825, which caused mass destruction to nearly 1/3 of the province. In 1923, 264 fires contributed to the largest area burned since keeping record consuming 165,759 ha. In contrast, 2011 had 81 fires, burning 45 ha.

Fire Smart- The Fire Smart website is up and running, located at gnb.ca/firesmart. We received 24 applications for Fire Smart Community wildfire resiliency plans and all were approved and were accepted by the communities. This equates to 2.6M in proposed spending. We are working with Indigenous community representatives to create cultural specific programming. If anyone is looking for presentations, please contact firesmart@gnb.ca Wabanaki Fire Crew- Year 2 of the program. We mobilized 2 crews to western Canada this summer and utilized the Wabanaki crew on several of the fires in New Brunswick during August and September. They have added experience to their training and have become a great resource for NB and for Canada.

**Training-** Mark III Pump kit rollout has been delayed due to the fire season. 20 kits will be delivered to the communities that are both high risk and historically have frequent fire starts. Additional kits will continue to be delivered over the next 3 years. Local District staff will deliver each kit on a scheduled training night and review the kit, pump use and a PowerPoint presentation will be provided.

**SPU (Structure Protection Unit) Program Development-** 2 Trailers are available. Training has been developed between the Fire Marshal's office and the DNRED Training Coordinator. This training will expand in the coming months.

**Fire Department social media-** Many fire departments share the provincial burn restrictions daily. While our department appreciates the additional residents who see these messages, we often see the feeds show these a few days after they are valid. When possible, please share the link to the current burn map or delete the previous day's message when sharing the new one.

#### **ASSOCIATION REPORT**

#### Southeast FF - Brad Calhoun

The Last SEFFA meeting was held on Sept 28<sup>th</sup>, 2025, with 12 departments represented. A guest speaker from wholesale fire rescue (Dan McCoy) was on hand to discuss equipment and services that they offer assisting members with dress uniforms and alterations.

#### Training

- A FF 1 Set to begin before the end of the year in the Tantramar region.
- Two Instructor 1's are planned, one for St. Paul and the other covering the Sackville area.
- St. Paul hosted an advanced rigging course that was sponsored by Advanced Rescue Training in September. This was well attended with positive feedback.

# **Random Thoughts**

- As an association, we are still beta-testing ways to improve attendance at meetings.
   Having a guest speaker or supplier in, providing supper, and having access to the meeting remotely are a few things we have tried to date.
- Planning is underway which would deploy "tanker task forces" as part of an automatic add plan for water supply. By breaking the association into zones, requesting a tanker should be easier than listing off each department being requested individually. More to come on this.
- We are on the back end of a busy forestry season. Our department members were required to back each other up frequently. As always, they worked seamlessly together, and their efforts are to be commended.
- Next meeting is scheduled for the first Sunday in December.

## Chaleur Association - Dwayne Stephenson

We held our last meeting on Oct 15th.

Our training schedule for this fall is going to be very light as we only have a French firefighter 1 going as we speak. There is one department looking to do an in-house English firefighter 1, which will be put out to the association to see if there are any interested. If no one is interested, it will be up to this department to organize its course. We have reached out via email to the association to attempt to get a list of students and wanted courses so we can set up our spring schedule.

We had the MBU in Bathurst, unfortunately, only 3 departments used the unit. While it was in the association, it was also hunting season. There was one small hic-up, which was resolved. We are going to work with Remi to get our schedule in place earlier next round.

It was also brought forward that fire chiefs should go to their councils, and get them to get a committee in place, or reactivated, to set forth plans for mass disasters (i.e., large forest fires). Due to the extreme fire in Miramichi, we feel it is pertinent to have communities ready for large-scale emergencies. To do this, we recommend implementing an emergency plan or bringing a current plan up to date. Reviewing said plans yearly and including the fire department in the review.

We are also looking at setting up an association-wide list of available firefighters, trained with EFF by the DNRED. This list would be the first called people in the event of a large-scale forest fire, and would save time as the people on the list would be ready to go. This list will require a yearly update before the forest fire season and would save time by not having to go department by department asking for manpower.

#### **New Business**


